When you RSVP to any event organized by LJR ,you are agreeing to the releases and indemnifies each of Let's Just Ride its organizers and representatives, together with the Facilitators (collectively the "Releasees") from and against any claim which the undersigned has or may have in the future against the Releasees arising from or relating to the ride in any manner whatsoever. The undersigned agrees not to make any claim or initiate any proceedings against the Releasees or any person, partnership, corporation or other entity which might be entitled to claim contribution against the Releasees arising from or relating to the ride in any manner whatsoever.

3. This Acknowledgement, Release and Indemnity shall be binding upon and shall enure to the benefit of the parties and their respective successors, assigns and legal representatives.

4. Participation in any ride with Lets Just Ride exposes you to risk of bodily harm, other physical dangers and potential death.
