

**Great Hyderabad Adventure Club**  
**Waiver and Release of Liability & Assumption of Risk**

**Rock Climbing. Bouldering. Rappelling Programme**

**Risks**

The risks involved in climbing or rappelling programs provided by the club include, but are not limited to:

- All injuries resulting from falling off the climbing surface and hitting rock, holds and projections or the ground.
- Rope abrasion, entanglement and other injuries resulting from activities on or near the climbing area such as, but not limited to, climbing, belaying, rappelling, lowering on a rope, and any other rope techniques.
- Muscular-skeletal injuries including pulled muscles/tendons, dislocations, broken bones, strains, and sprains.
- All manner of injury resulting from environmental factors including sunburn, heat stroke, heat exhaustion, hypothermia, headaches.
- Injuries resulting from slipping, falling down, falling climbers, rocks or dropped items, such as, but not limited to, ropes and climbing hardware.
- Cuts and abrasions resulting from skin contact with the rocks or the ground.
- Failure of ropes, slings, bolts, cables, climbing hardware, anchor points.

**Release of Liability**

- I understand and acknowledge that the activity (program) I am about to voluntarily engage in bears certain known and unanticipated risks which could result in injury, death, illness, disease, emotional or psychological or physical distress, damage to myself, property or to third parties.
- I expressly agree and promise to accept and assume all of the risks existing in this activity (program). My participation in this activity is purely voluntary. No one is forcing me to participate, and I elect to participate in spite of the risks.
- I waive my right to make a claim or file a lawsuit against the Organisers or members of the Great Hyderabad Adventure Club if anyone is hurt or any property is damaged during my participation in and travel to and from this activity (program).
- I affirm that I am in good physical health and have no significant ailment or medical conditions that would counter-indicate any disability to take part in the outdoor activity.
- Rules and regulations have been adopted for the safe enjoyment of this program by all participants and I agree to adhere to those regulations.
- I hereby give permission for the Great Hyderabad Adventure Club and its Organisers to secure medical treatment for me in the event of an emergency. I authorize the physician or medical personnel or Certified First Aider present to provide whatever treatment deemed necessary by them.

**I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify the Organisers and members of the Great Hyderabad Adventure Club from any and all liability, claims, demands, actions or rights of action, which are related to, arise out of, or are in any way connected with my participation in this activity (program).**
