I hereby release, waive, and discharge Springdale Area Recreation Club, and their Board of Directors, members, representatives, and sponsors from all claims, demands, liabilities, rights and causes of action of whatever kind or nature, that may result from or occur during my participation in the 2012 Springdale Open Doubles Tournament, whether caused by negligence of the club, the Board of Directors, members, representatives, sponsors or otherwise. I also agree to indemnify and hold harmless Springdale Area Recreation Club for any loss, liability, damage or costs, including court costs and attorney's fees that may occur as a result of my negligent or intentional act or omission while participating in the 2012 Springdale Open Doubles Tournament.
