**3. Health**

The owner certifies that their dog is: in good health, up to date on rabies, Bordetella, and DHPP vaccinations, has not been sick during the last 45 days and is free from any communicable disease.

**4. Responsibility**

The owner is fully responsible for any harm that may be caused by their dog while under the care of ADDO, LLC.

**5. Representation**

The owner recognizes that the staff at ADDO, LLC has agreed to accept their dog for care based upon the information provided by the owner. The owner is presenting their dog as being free of threatening or aggressive behavior and certifying that the dog has not harmed any other dog or person.

**6. Liability**

The owner agrees that the ADDO, LLC and its staff and volunteers will not be held liable for any problems or injuries that may occur while the dog is in the care of ADDO, LLC. The owner releases ADDO, LLC from all claims of any kind.

**7. Treatment**

In the event of an injury or other problem involving a dog, ADDO, LLC will attempt to contact the owner in order to discuss treatment of the dog and/or call your veterinarian. The owner recognizes that the staff of ADDO, LLC must exercise its best judgment and discretion in dealing with the situation on a timely basis.

The owner agrees to accept full financial responsibility for any medical treatment that may be required.

**8. Right of Refusal**

ADDO, LLC has the right to reject any dog that becomes aggressive or threatens to harm other dogs or staff, or that is discovered to have fleas or becomes ill.

**9. Reasonable Care**

ADDO, LLC will provide quality and reasonable care for dogs left in its care, but can not provide constant observation of every dog.

**10. Pet Profile**

The owner must also complete the Pet Profile.

**11. Fees**

The fees are subject to change. The fees displayed on company brochures available in the ADDO reception area take precedence over those included in this paper.

Daycare - \$30 per day

ADDO daycare passes are available reducing per day fee.

\* 33% discount on each family dog after the 1<sup>st</sup>.

Boarding - \$50 per day (includes cage-free daycare all day)

\* 33% discount on each family dog after the 1<sup>st</sup>.

\* Daycare & boarding dogs must be picked up by close of business or overnight care will be provided & appropriate charges will be made.

\* There is a one day dog daycare charge for no-shows (daycare only) with less than 24 hours notice.

\* Prices/ & Discounts are subject to change. Paid reservations ensure your dog's space at ADDO.

**12. Reservations**

Reservations are required. All reservations are final. Any cancellations with appropriate notice are viewed as ADDO credit for your dog's next visit (to be used within 6 months from date of canceled reservation). There is no refund policy.

**13. Hours of Operation**

Daycare: Monday – Friday 7am – 7pm

Saturday & Sunday 9am – 6pm

Boarding: All dogs can arrive as early as start of daycare and must arrive to ADDO no later than 3pm every day.
