A dog may be entered in one regular class only except dogs who have earned their ME title. Dogs may move up to the next Regular class the day they title for the next day but may NOT move up to the next regular class the same day that they title.

ELIGIBILITY:

This test is open to breeds listed on 1st page and dogs certified as eligible according to "Regulations for Earthdog Tests for Small Terriers and Dachshunds", published by the AKC.

Dogs must be over the age of 6 months.

Spayed, neutered, limited registration and ILP dogs are eligible to participate.

Bitches in season, aggressive dogs, dogs that are blind or deaf or suffering from any deformity, injury, or illness that may affect their physical or mental performance are not eligible to participate. No dog shall compete if it is taped or bandaged or in any way has anything attached to it for medical purposes.
