- 1) **Event will be held RAIN OR SHINE.** Chanel Prada Events will provide each vendor with a **10" x 10" canopy (no sides), lighting (1 light only), a 6" x 2" table and 1 chair.** **This is an outdoor event.** Exhibitors must provide any display racks and demonstration equipment sturdy enough to withstand crowds and weather.
- 2) **Exhibitors are responsible for providing extension cords (12 gauge or larger, 3 wire), any additional chairs or other set up equipment if needed.** Food Vendors will be allowed to have a maximum total of two (2) small propane tanks (for cooking purposes). **All equipment is subject to inspection by The Graham Companies' Electrical Inspector and must be approved prior to the start of the event.**
- 3) Food exhibitors must maintain a specially clean and professional manner when handling all food products, including but not limited to: gloves, hats/ hair nets, hand sanitizer, consistent pattern/color of uniform.
- 4) Food/ cooking exhibitors must maintain a safe and clear work area and are required to have at least one (1) fire extinguisher within immediate reach of cooking area.
- 5) Exhibitors are responsible for a professional display. **Full length table covering is mandatory for all tables.** Colors approved are white or black. Other colors must be pre-approved by the Festival Committee.
- 6) The exhibitor is responsible for keeping assigned area clean throughout the festival and is required to have at least one (1) trash can with lining. Each exhibitor shall return the assigned area to its original condition. **\$25.00 deposit will be returned after post-inspection of booth between 9-10pm. NO EXCEPTIONS.**
- 7) **The Graham Companies** reserves the right to limit the number/type of vendors. The Graham Companies may reject any vendor or ask the exhibitor to leave the event without refund if the display is deemed inappropriate for the event. **The Graham Companies and Chanel Prada Events** will work with each exhibitor to determine the best location for their display emphasizing no conflict with the Main Street merchants.
- 8) Space is limited. **Applications deadline is Wednesday, February 9, 2010.** The Graham Companies and Chanel Prada events will work with each exhibitor to determine the best location for their display emphasizing no conflict with the Main Street merchants. **Booth**

**location will be provided to participants during vendor orientation February 16, 2010.**

**On February 19, 2010 vendors will receive their final booth location to include final participants; any changes in booth location from original layout must be agreed by all parties. NO CHANGES AFTER February 19, 2010. NO EXCEPTIONS.**

9) Applications for booths or displays for candidates for public office or organizations promoting political causes will not be accepted for the festival.

10) Cancellation and request for refund must be made prior to noon, Wednesday February 9, 2010. A \$50.00 cancellation fee applies to all refunds. No refunds will be issued after Noon, February 9, 2010, NO EXCEPTIONS!

11) Vendors can arrive/set-up by 7am and MUST be set-up by 10am. **Vendors that are not set up and/or no show by 10.00 am may be reassigned to a different booth number or cancelled participation in the Festival with no refund at discretion of the Festival committee.**

Make sure you have the supplies you need for a professional set-up, ropes for banners, displays, tape, staples, etc.

**VENDORS SHALL NOT BREAK DOWN PRIOR TO 9PM or deposit will not be refunded.**

**ON THE DAY OF THE FESTIVAL- ALL EXHIBITORS MUST REPORT TO THE INFORMATION BOOTH BY THE STAGE BY 10AM.**
