






## Ignore the rhetoric - here is the actual record of **RICK PERRY**:

The **TRANS TEXAS CORRIDOR (TTC)** orchestrated and championed by Rick Perry against the will of citizen interest groups is a gargantuan, multi-billion dollar toll road fiasco with its "Comprehensive Development Agreements" (**CDAs**) benefitting foreign corporations and friends at the expense of Texas drivers for every future generation to come.

- "Want to know why there's no money for roads? Here's your answer. We're paying (bid) *losers* for not even building the roads. The cronyism is only getting worse, and it's at the expense of the taxpayers." – Texans Uniting for Reform and Freedom (TURF) founder, Terri Hall on \$3,615,214 payment to **Spanish corporation Cintra** for a losing bid.
- "We need government in the sunshine. I'm calling on Governor Perry to order his transportation department to drop its lawsuit (protecting Cintra-Zachry from public information requests) and release to all Texans the **secret contract** with a foreign company." – Carol Keeton Strayhorn in May 2006 campaign for Texas Governor.
- "RiskMetrics critiques the financially-engineered infrastructure (toll road) model for its high debt levels, high fees, paying distributions out of capital rather than cash flow, overpaying for assets, related-party transactions, booking profits from revaluations, poor disclosure, myriad conflicts of interest, auditor conflicts and other poor corporate governance." – *CorridorWatch.com* fears TTC deals will be a disaster and cites "**Macquarie model blowtorched**" report published by the New York RiskMetrics Group on Public-Private Partnership revenue model risks.

As governor, Rick Perry tried to bypass the Texas legislature and **mandate via order of the Governor** that all sixth grade girls be **forced to take the HPV vaccine Gardasil** developed by international drug maker Merck. The disregard for rights of Texas family children exposes his unimaginable allegiance to big business versus the free people of Texas.

- "The majority of Texans and the majority of the Legislature want to leave that decision to parents. All the governor had to do was talk to us and he would have seen that we have embraced a program where there is an opt-in instead of an opt-out" Lt. Gov. David Dewhurst, Dallas Morning News, May 9, 2007

As governor, Rick Perry orchestrated another public private partnership in the form of a **Texas Enterprise Fund** where taxpayer dollars are doled out to special interests selected in large part by **his own office** – a total conflict of interest.

- "Perry's **Texas Enterprise Fund** nods its head to the ideas of creating actual jobs and accountability, but is in reality a corporate welfare **slush fund**" as reported on the *BurntOrangeReport.com* Wednesday, January 23, 2008

Governor Rick Perry **swept three appointees from their jobs** just two days before they were set to critically examine a flawed arson investigation that contributed to the execution of a Corsicana man.

- The hearing of the Texas Forensic Science Commission, scheduled for Friday in Irving, was abruptly canceled by the new chairman the governor chose, Williamson County District Attorney John Bradley. He is considered one of the most conservative, hard-line prosecutors in Texas. (Dallas Morning News – October 1, 2009)

## And here is the so called "conservative record" of **Kay Bailey Hutchison**:

- Pledges to serve only two terms as Senator – then **disregarding her pledge runs for a third term in 2006**.
- Promises to freeze federal discretionary spending – then **supports 99% of federal discretionary spending**.
- Vows to balance federal budget and reduce \$4.4 trillion debt and criticizes opponent for having voted for 94% of all spending bills – then she **votes for 98% of spending bills** and votes to raise the national debt ceiling ten times up to \$12.1 trillion.
- Scorns "Washington handlers and image-makers" – then hires non-Texas mercenaries with **Washington ties** to run her campaign for the Governor of Texas.
- Considers earmarks wasteful spending saying "Our children and grandchildren must pay for it for years to come" – then is enshrined in the "**Porker of the Month Hall of Shame**" by **Citizens against Government Waste** for inserting 346 earmarks into last two years' spending bills costing taxpayers \$2.6 billion.
- Supports prohibiting federal candidates from accepting contributions from foreign lobbyists – then accepts thousands of dollars in contributions from **foreign lobbyists**.
- Criticizes deficit spending in Washington saying "We cannot afford to continue to spend ourselves into debt" – then votes for the **\$787 billion Wall Street bailout** with subsequent financial bailout programs that have cascaded into financial obligations beyond the ability of taxpayers to repay without destroying the dollar. Current taxpayer obligations are now beyond **\$4 trillion, \$10 trillion, 20 trillion, \$30+ trillion**.
