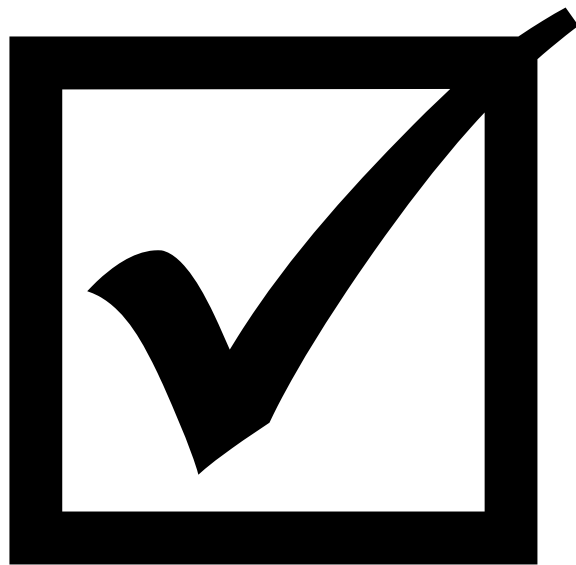

## What is a PCO?

A 'Precinct Committee Officer' is an elected office and is the local representative of a political party in Washington State. A grassroots, neighborhood organizer.

## Why should I become a PCO?

## **How do I get elected?**

After you've filled in the Candidacy form your name will be on the ballot in your precinct in the August 19th primary election. You need to get at least 10% of the number of Republican votes in your precinct if only you are on the ballot. If you are opposed for the PCO position then you also need to receive more votes than your opponent. There are two easy ways to win. The first is to make sure all of the other Ron Paul supporters in your precinct know you are running. The second is to visit as many of the other Republicans in your precinct. A great reason to say hi is to let them know you want to help deliver the precinct for the small government Republicans and because you are running for PCO! We can help you get the list of other Republicans in your precinct.

## **What am I expected to do?**

Get elected and be willing to vote for honest, constitutionally minded party leadership at a couple of meetings. That is all we are asking you to do. What you make of the position and how far you want to go in the effort to save this country is up to you!

- **Declarations of Candidacy will be accepted by mail beginning May 16, 2008, and must be received by King County Elections not later than June 6, 2008, at 4:30 p.m. Declarations received after June 6, at 4:30 p.m. will be rejected regardless of the postmark. (RCW 29A.24.081)**
- **Declarations of Candidacy will be accepted in person or by fax at the office of King County Elections beginning on June 2, 2008, at 8:30 a.m. and ending on June 6, 2008, at 4:30 p.m. (RCW 29A.24.040 and 29A.24.050)**
