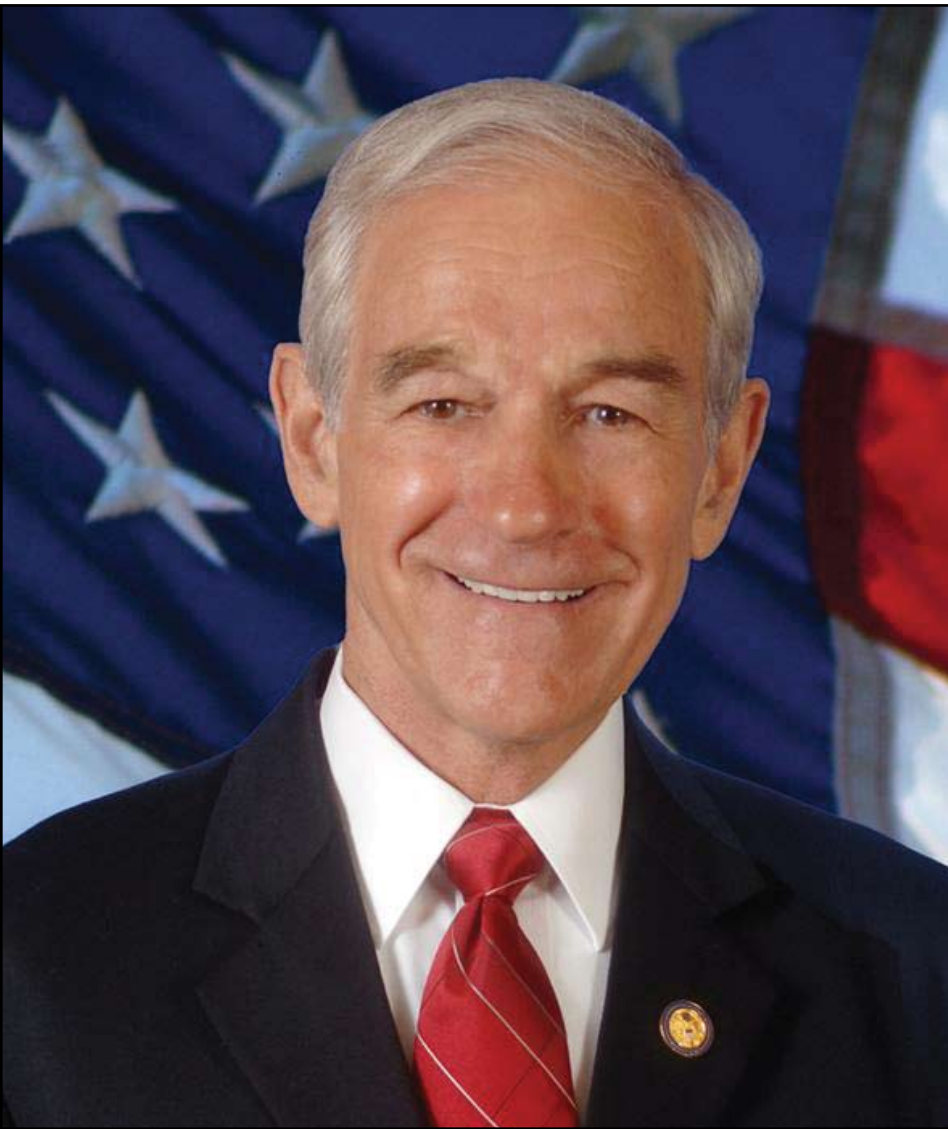

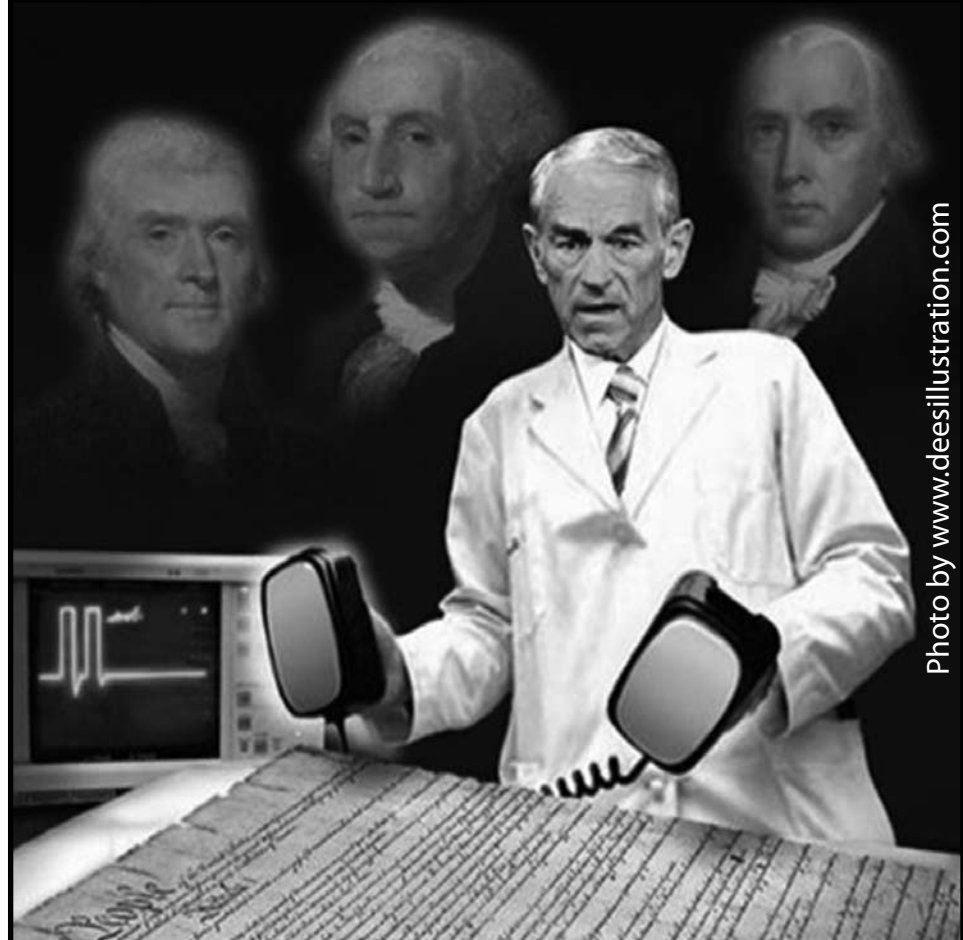

- America will lose its indepen-

dence and get merged into a North American Union by 2010 with a North American Parliament, North American Military, North American court system that supercedes the Supreme Court, and a North American currency called the Amero. The Constitution and Bill of Rights will be scrapped and a redacted, politically correct version will be created that embraces all of North America.

- The FDA and the CDC will come under the authority and direction of the World Health Organization and the United Nations. Resisters will either be forcibly injected against their will or sent to a federally designated quarantine center for an unspecified period of time and classified as a public health threat.
- Federally mandated screening of the entire population for mental health issues and the forced drugging of everyone diagnosed with a disorder. (The screening is designed to make virtually everyone fail so they receive a prescription.)
- Universal Health Care Coverage will be passed and all health care will become socialized and further regulated by the feds. Under a democratic administration coverage will also include abortions and possibly stem cell therapy and gender alterations. In addition, the 50 million plus illegal Mexicans now living in the U.S. will be allowed free access to the system with preferential treatment over natural born, tax-paying U.S. citizens. putting a stop to the absurd fees hospitals and doctors charge patients is part of the answer to the problem, not more federal control that empowers drug companies, insurance companies, and hospitals.]

- Microchip implants will be required for Alzheimer's patients, the elderly living in nursing homes, high risk patients with heart disease, cancer, those on dialysis, and the illegal aliens given amnesty.

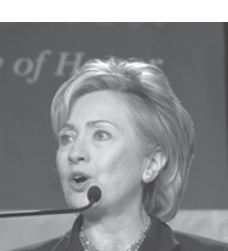

Here's a brief review on where the leading candidates stand on health freedom issues.



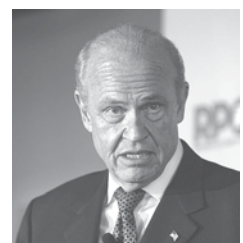
Hillary Clinton:

I can assure you that as a big pharma representative, Giuliani would support the complete destruction of the di-

etary supplement industry and the implementation of CODEX.

Despite his pro-American rhetoric, he is really an internationalist. While Giuliani denies being a member of the Council on Foreign Relations, he says he lives close to their headquarters and goes by their office all the time; that he has spoken to their group, and doesn't think there would be anything wrong with being a member. He says they are a terrific organization that lends a lot of thinking to foreign policy.

Mitt Romney:

Mitt Romney has just unveiled a health plan to help cover the nation's uninsured, based on tax incentives and insurance reform. The plan itself is based on the book **Health, Wealthy, and Wise**, published by the American Enterprise Institute (AEI). AEI is of course the neo-con think tank responsible for the Iraq war. AEI members like Scott Gottlieb shuttle between Wall Street and top positions at the FDA, seeking to rush new drugs to the market for the profits of Wall Street at the expense of consumer safety and proven effectiveness of the drugs. Rest assured, the only plans AEI sponsors are those that financially benefit its ultra-rich globalist members, not the American public that will be saddled with the bill.

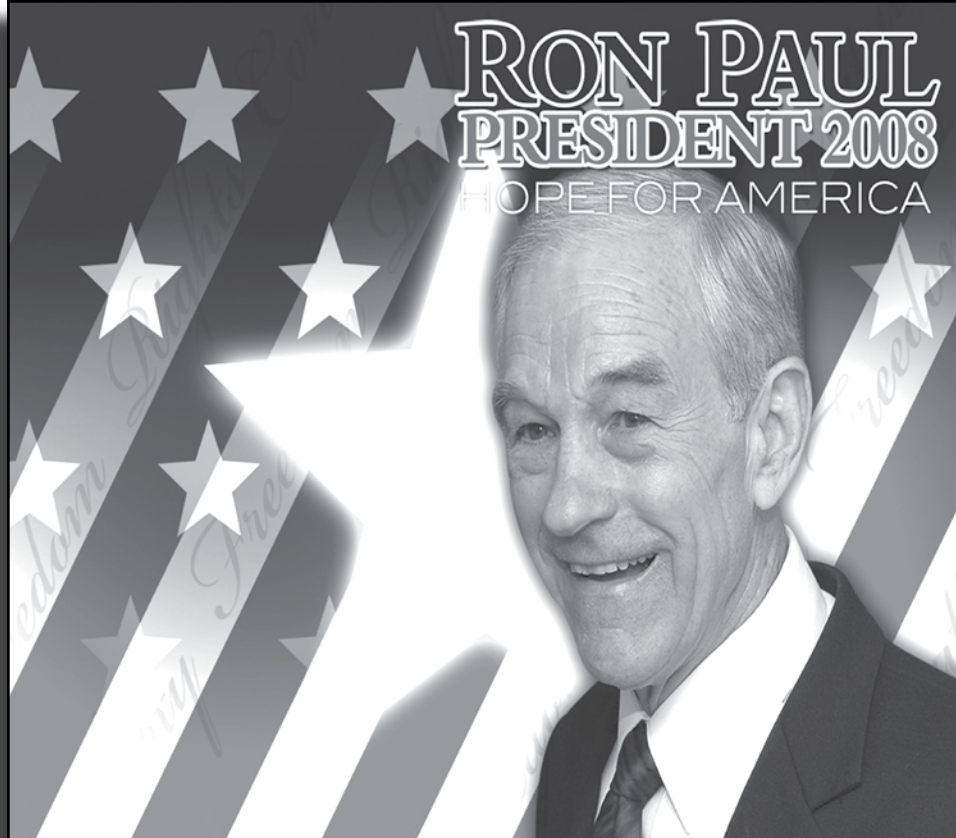

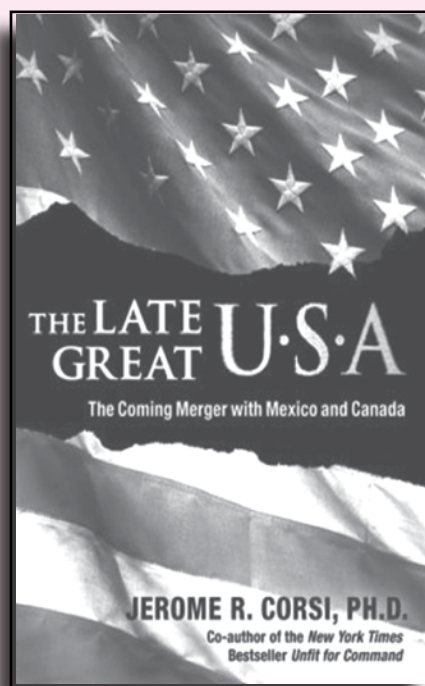
