WAIVER AND GENERAL RELEASE OF CLAIMS AND COVENANT NOT TO SUE

I, the undersigned, fully understand, appreciate and agree that I have voluntarily requested to participate in an event entitled "Dog Day" at PETCO Park, which will involve my attendance and the attendance of one dog of which I have custody, at PETCO Park. I understand that by participating in this event, my actions may result in anticipated and/or unanticipated injuries and damage to myself and others including my dog as well as the dogs of others. I hereby represent that the dog of which I have custody during the event is in good health. I confirm and assure that the dog has current rabies vaccinations. I agree to abide by any decision of any Padres official, or contracting working on behalf of the Padres, concerning my ability or the ability of the dog of which I have custody to participate in this event safely, and I further agree that Padres officials may authorize necessary treatment for me and/or the dog in my custody. I assume any and all the risks associated with my participation in this event including, but not limited to, risk of or associated with injury and property damage including injury to dogs, illness, falls, contact with spectators at the event, injuries or damages sustained by and through other participant dogs, the effects of the weather including extreme temperature and humidity, the condition of the premises and PETCO Park, including all sidewalks and parking lots, and it is understood and agreed that all such risks are appreciated by me. I agree to abide by all the rules and instructions given in connection with this event. I assume the risk for injuries and damages sustained as a result of the manner and method by which the event is administered. I acknowledge that I have completed the "Dog Day 2007 Application," I understand that I am solely responsible for the accuracy of information that is contained therein and I hold the parties as identified below released from liability and any responsibility for verifying the information contained in the applications and whether the information was provided by me or a third party.

I, the undersigned, have read this waiver and I am competent to sign the waiver with full understanding of the above information.
